The investment strategy also takes into account sustainability indicators, the so-called ESG criteria, which are based on data on the sustainability of individual investment instruments provided either by their issuers or MSCI. Selected are investment instruments whose investment policy is aimed at avoiding or reducing risks in the sustainability area. When choosing suitable tools, the following indicators are mainly assessed with focus to sustainability:

- ESG rating
